**Subject: Continuation of recognition of MBBS degree granted by Dr. Ram Manohar Lohia Avadh University, Faizabad, Uttar Pradesh in respect of students being trained at Hind Institute of Medical Sciences, Barabanki, Uttar Pradesh - regarding.**

Sir/Madam,

I am directed to inform you that an assessment to assess the physical and the other teaching facilities available for continuance of recognition of MBBS degree (100 seats) granted by Dr. Ram Manohar Lohia Avadh University, Faizabad, Uttar Pradesh in respect of students being trained at Hind Institute of Medical Sciences, Barabanki, Uttar Pradesh was carried out by the Council's Assessors on 28<sup>th</sup> & 29<sup>th</sup> August, 2019. The said assessment report along with the summary/observations of the member of the UG Expert Group was considered by the Board of Governors and it was decided to recommend that recognition of MBBS degree granted by Dr. Ram Manohar Lohia Avadh University, Faizabad, Uttar Pradesh in respect of students being trained at Hind Institute of Medical Sciences, Barabanki, Uttar Pradesh be continued restricting the number of admission to 100 (one hundred) students.

The Board of Governors also decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

- (2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute....."

It is further to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material etc. throughout, as stipulated in Regulation of Medical Council of India. In case false/wrong declaration of fabricated documents have been used for procuring the approval of Continuation of recognition by the Council and the said misconduct is brought to notice, or comes to the knowledge of MCI at any stage, your institution is liable not to be considered for approval of continuation of recognition with the annual intake capacity of 100 students and this approval is also liable to be revoked. Besides, MCI is entitled to take all such measures against you and your college/institution as permissible under the law.
