Subject: Dr. Ram Manohar Lohia Avadh University, Faizabad- Recognition of MD(Forensic Medicine) qualification for 2 seats in respect of students being trained at Hind Institute of Medical Sciences, Barabanki.

Sir/Madam,

I am directed to state that the Board of Governors considered the compliance Verification Assessment report (28.05.2019) along with the Council Assessor's Report(s) (September, 2017) on the standard of examination and other teaching facilities for Recognition of MD(Forensic Medicine) qualification for 2 seats at Hind Institute of Medical Sciences, Barabanki granted by Dr. Ram Manohar Lohia Avadh University, Faizabad and Committee decided as under:-

"The Board of Governors considered the compliance Verification Assessment report (28.05.2019) along with the Council Assessor's Report(s) (September, 2017) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Forensic Medicine) qualification for 2 seats granted by Dr. Ram Manohar Lohia Avadh University, Faizabad in respect of students being trained at Hind Institute of Medical Sciences, Barabanki be recognized and included in the 1st Schedule to the I.M.C. Act, 1956. The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

It is further to inform that MD(Forensic Medicine) qualification has been recognized and included in the 1st Schedule to the I.M.C. Act, 1956 as per Gazette Notification dated 01.03.2019 in respect of only the four batches admitted in 2013. (copies enclosed)

You are therefore requested to issue an appropriate notification recognizing the above qualification on or after 2016 instead of students admitted for the academic year 2013-14, 2014-15, 2015-16 and 2016-17.
