I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 10/10/2017 considered the Council Assessor's Report (21st & 22nd September, 2017) on the standard of examination and other teaching facilities for Recognition of MD(Microbiology) qualification for 4 seats at Hind Institute of Medical Sciences, Barabanki granted by Dr. Ram Manohar Lohia Avadh University, Faizabad and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (21st & 22nd September, 2017) and decided to recommend to the Central Government that MD(Microbiology) qualification for 4 seats granted by Dr. Ram Manohar Lohia Avadh University, Faizabad in respect of students being trained at Hind Institute of Medical Sciences, Barabanki be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
